e. That the Trust Fund may be augmented by the income from the initial fund and also by donations and other contributions from time to time.

f. That the Trustees shall always maintain proper accounts of the Trust, which shall be kept at the office of the Trust.

II(B) Beneficiaries of the Trust

The Trust is established for the benefit of educationally, socially and economically weaker, oppressed and depressed persons of all walks of the society and irrespective of the caste, creed, sex, religion etc.,

II(C) Commencement & Duration of the Trust : This Trust is already commenced from **01-12-2018** and the duration shall be **At Will**.

III. Properties, Donations and Contributions

The Trust properties shall consist of

1. The amount transferred by the SETTLOR as mentioned above towards the Corpus Fund of the Trust

2. The immovable properties and other assets transferred, if any, by SETTLOR or other donors

3. Any cash or kind, properties, movable and immovable that may be acquired by purchase or otherwise of all manner of rights, title or Interest in or over any property movable or immovable

4. The Trustees shall have power and discretion to accept upon such terms as they shall think fit any donations, grants, subscriptions, aid and contributions both in cash and kind from the Settlor and from any Government, Statutory Bodies, International Organisations, Corporations, Institutions, Firms, Individual persons or from any Charitable Institutions, Philanthropists or other Institutions including International agencies and Non-Resident Indians, Persons of Indian origin provided always that the terms upon which they shall be accepted should not in any way be inconsistent with or repugnant to law or the provisions contained in these presents

5. The Trustees shall apply such donations, grants, aid, subscriptions and contributions for all or any of the objects of the Trust keeping in view the objects of the Trust and the intentions of the Settlor. Donations may be received by the Trustees in cash or in kind and either as forming part of the Corpus of the Trust or otherwise

IV – Investments

All monies which are not immediately required for current expenses shall be invested by the Trustees in Investments and Securities, authorized by applicable enactments for the time being in force for the investment of Trust funds and in particular according to the provisions of Section 11 (2)(b) of the Income Tax Act, 1961 (as prevailing at present), or any statutory modification thereof or other similar provisions, or in Fixed Deposit or Saving Deposit Account in any Scheduled Bank or Banks as defined in the Reserve Bank of India Act or in Post office or in immovable property.

V. Board of Trustees, Their Term and powers to Co-opt

- 1) Sri **Tirumalasetty Lakshmaiah Naidu**, aged 41 years, son of Sri T. Venkateswarlu, residing at Door No.7-143, Water Tank Road, Swarna, Prakasam District, Andhra Pradesh - 523 170,
- 2) Sri. **Boyina Sree Devi**, aged 42 years, W/o. Sri Boyina Swamh, residing at Door No.18-197, Opp. Vuda Apartments, A.U.Engineering College Road, Visakhaaptnam-530 003, Andhra Pradesh,

(Herein after called as Trustees/ Managing Committee Members" which term or expression shall, unless excluded as being repugnant to the subject or context, mean and include the Trustees for the time being these presents, their nominees, successor or successors in office, Executors, Administrators and Assigns etc., of the other part)

1) The Management of the Trust shall vest with Board of Trustees consisting of Trustees as detailed below:

a) Trustees : Not more than 50

b) The contributions received at the formation of the Trust or subsequent payments received from the existing and other members after formation of the Trust shall be treated as donations and such members shall not have any say in the affairs of the

Trust. However they are eligible to be appointed / nominated as Trustees in case any vacancy arises as mentioned in clause V (d) .

c) The Trustees shall hold office for two years and are eligible for reappointment for a term of another two years. No trustee shall be appointed for more than two terms successively.

d) The Board of Trustees shall have power to terminate the Trusteeship of any Trustee if He/ She acts in a manner, which is detrimental to the objects of the Trust or engaged in such acts, which are prejudicial to interests and objects of the Trust. In all such cases, the decision of the majority of Trustees shall be final.

e) The Trustees shall be persons of standing from any walk of life or profession including Industry, Education, Public Administration, Literature, Fine Arts, Social Service etc and be persons of good character and reputation and not involved in any criminal cases or convicted in Criminal Cases.

f) The Trustees who are unwilling to continue can give 15 days prior notice for his/her cessation of Trusteeship and in such case, the Managing Committee / Board shall have the right to nominate any person as Trustee in his / her place. The decision of the majority of the Board / Managing Committee shall be binding in case of all matters including policy decisions.

g) The Trust Board can change the nomenclature of the Trustees as per requirements as mutually agreed by them.

h) The Trust Board shall also have powers to constitute Managing Committee and Sub-committees for operational convenience by nominating the Trustees to the Sub-committees and designating them as office-bearers of such Committee. The Managing Trustee of the Trust shall be the President of all such Sub-committee/s unless decided otherwise by the Trustees. The objects, powers of such Sub-committee, its term of office, quorum, proceedings and other terms and conditions shall be decided by the Trust Board from time to time.

i) In all matters, the decision of the Trust Board is final and is binding on the Managing Committee and all Sub-committees.

j) Advisors: A person who is actively rendering social service, is well known and well regarded among the society may be nominated / appointed as Advisor by the Trustees. Such Advisors hold an honorary position and need not contribute to the Trust. Such Advisors shall not be more than 12 in number. Such Advisors shall hold the office for two years and are eligible for re-appointment for another term of two years but cannot be appointed successively for more 2 terms and shall not have any voting rights.

VI. Term of Office and Managing Trustees

a) The Board of Trustees shall have the power to fill the vacancy of Trustees up to the maximum number stated in clause v (1) and fix their term of office as per provisions contained herein.

b) Any vacancy in the office of the Managing Trustee shall be filled up by electing one of the existing Trustees as Managing Trustee by Members present by majority vote. Such person shall hold office for such period as mentioned in clause (a) above.

VII - Powers of the Board of Trustees

a) The Board of Trustees shall have all powers necessary or incidental for effective functioning of the objects of the Trust.

b) Subject to the general provisions of the Trust and without prejudice to the general and specified powers conferred upon the Board of Trustees by the other provisions contained in these presents the Board of Trustees shall have the following powers:

1) To apply the Trust monies to effectuate all or one object or some of the objects of the Trust in preference to the other object.

2) To discontinue the application of the Trust funds to one object and or divert the funds to another object.

3) To decide upon the nature, objectives and functions of the institutions to be assisted by the Trust in any manner.

4) To prepare Annual Budget including Revenue, Capital and Investment proposals.

5) To decide what terms and conditions shall be complied with by institutions / persons to whom financial or other aid or assistance is given.

- 6) To determine the terms and conditions on which any donation, subscription, financial assistance, scholarships or prizes or awards are to be given by the Trust and frame rules for that purpose. In all such matters the decision of the Board of the Trustees is final.
- 7) To increase the funds of the Trust in such manner as they shall consider most beneficial for the interest of the Trust.
- 8) To accept contributions in money or property, movable or immovable or by cash / securities either by way of addition to the Trust funds generally or for any one or more of the specified objects of the Trust.
- 9) To acquire Movable Property for the Trust with Trust funds.
- 10) To operate Bank accounts including Saving Account, Current Account, FD, Over Draft and Loan accounts on behalf of Trust.
- 11) To take property on lease or hire or to grant lease of the Trust, its immovable and movable property or any such property on such terms as they think proper.
- 12) To settle out of court, compromise or compound all suits, actions and other proceedings and refer all differences and demands to arbitration and to execute release documents and to settle and approve all actions prudently without being answerable for any loss caused thereby.
- 13) To institute, conduct, defend or abandon any legal proceedings by or against the Trust or Trustees and allow time and indulgence for payment or satisfaction of any debts, dues or any claim or demand by or against the Trust.
- 14) To obtain payment of money from all Courts, Banks, Government Offices, Treasury, Official Assignees, Official Receivers, Post Offices and all other Offices of the Central, State or Local Authorities and Institutions, persons or Legal entities.

- 15) To appear before the officials appointed for registration of Deeds, Assurances, Documents and other Instruments in order to execute or confirm and admit execution and register or cause to be registered any Deed, Assurances, Documents, etc., in which the Trustees are interested or involved.
- 16) To delegate any power which is lawfully allowed to be delegated to any person and to execute such Power of Attorney as he may think fit for the purpose.
- 17) To generally do and perform all things required or necessary to be done or performed in or for achieving the objects of the Trust.
- 18) The Board of Trustees shall exercise their powers by a majority decision or by obtaining written majority concurrence of Trustees by circulation of the proposal.
- 19) To form Sub-committees of the Trustees and to delegate powers to such committees and secure their accountability with due propriety.
- 20) To buy, acquire or take on lease or otherwise, immovable proprieties for the Trust and or put up buildings or structures on the land belonging to or under the control and possession of the Trust and to sell, mortgage, charge or alienate in any manner of any immovable property of the Trust for attaining the objects of the Trust. However the above transactions shall be approved by a resolution by 2/3rd majority of the Trustees of the Trust Board present or 5 trustees whichever is higher,
- 21) To let out any portion of any immovable or movable property forming part of the Trust fund or property for such consideration and for such period and on such terms and conditions as they deem fit.
- 22) To convert, call in, sell, or otherwise dispose of any of the investments comprised in the Trust property or reinvest or change the nature of any other investment contained therein.
- 23) To borrow loans from outside including from Banks, Financial Institutions and other charitable organizations for the purpose of the attainment of the objects of the Trust and to mortgage, hypothecate, create lien over the assets of the Trust in favour of the Banks / Institutions.
- 24) To appoint, recruit or otherwise employ or engage the workforce, volunteers and other active participants to carry out the objects of the Trust and to finalize their

appointments / nominations etc., and terms and conditions thereof and period of their appointment or deployment in the executive activities of the Trust from time to time.

The above activities may be carried out generally by the Board of Trustees by themselves or it may delegate the powers to Managing Committee or to the Sub Committee of the Trust or delegate powers to Managing Trustee as decided by the Trust from time to time and the terms and period of delegation shall be specified by the Board of Trustees..

VIII – Proceedings of the Trust Board

- 1) The Trustees shall hold such meetings as may from time to time be necessary for considering any matter connected with the Trust or its affairs or to transact any business of the Trust and such meetings may be held at such places and as decided from time to time or at the Registered Office of the Trust by Managing Committee / Board.
- 2) The Board of the Trustees shall meet at least once in three months and not less than four such meetings must be held in a year.
- 3) The quorum for the meeting shall be one third of the Board of Trustees or three whichever is less.
- 4) The Trustees may make rules for regulating their meetings not being inconsistent with any provisions contained in these presents and also make rules for passing any resolutions by circulation among the Trustees. The Board of Trustees / Managing Committee may repeal or alter or modify any rules made pursuant to this clause to better serve the objects of the Trust.
- 5) A meeting of the Board of Trustees may be called by the Managing Trustee with not less than seven days notice in writing, specifying the date, place and hour of such meeting and nature of the business to be transacted at the meeting and such notice shall be sent by post or delivered in person. The accidental omission to give notice to or the non- receipt of notice by any Trustee shall not invalidate the proceedings of any such meetings. With the consent of all Trustees, a meeting may be convened at such shorter notice in such manner as the Board of Trustees may think fit.
- 6) The Managing Trustee for the time being shall preside over every meeting of the Trustees. If for any reason the Managing Trustee is not present, one of the Trustees

present at the meeting may be elected as Chairman of the meeting. However, at such meeting only business relating to routine matters shall be considered whatever be the agenda for which notice has been given.

7) A Minute Book shall be maintained in which all the proceedings of every meeting of the Trustees shall be recorded.

8) If any of the Trustees is interested in a particular matter, he/she should disclose it to the Trustees and recuse himself/herself. If allowed to be present his/her presence shall not be counted for the purpose of quorum.

9) The continuing Trustee or Trustees may act notwithstanding any vacancy in the body. In all policy matters and the matters relating to properties of Trust, the opinion of the Life Trustees shall prevail.

10) All acts done by the Trustees or any of them or by any person acting at the instruction of any Trustees shall, notwithstanding that it be afterwards discovered that he or she was disqualified, be as valid as if every such person had been duly appointed and was qualified to be Trustee.

11) The Trustees may appoint any Trustee or other person as approved by the Board of Trustees to attend to or carry out any special function connected with the management of affairs of the Trustees.

12) The Trustees shall be entitled to reimbursement of all expenses incurred by them for the purpose of the Trust or for attending the meetings of the Trustees as decided by the Trust.

IX- Registered Office

The Registered Office of the Trust shall be located in **Door No.55-41-11/2(1), Flat No. GF-2, SVR Residency, Ambedkar Nagar, Seethammadhara, Visakhapatnam 530013.**

It can have its other offices at any other place within India and representative office abroad by a resolution of the Board of Trustees from time to time.

The Managing Trustee for the time being shall have the custody of all Deeds and Documents of title relating to the Trust Properties and Investments and the Books of Accounts and all other records relating to the Trust and shall be responsible for the same.

XI. Bank Accounts

1) That the Trust shall open an account with any Scheduled Bank as decided by the Trustees of the Trust and all income, subscriptions and pecuniary donations received shall be treated as receipts of the Corpus of the Trust and the income on investments and all other monies from time to time forming part of the general revenue of the Trust shall on the same being received, be deposited in Bank Accounts.

2) The Trust may open one or more Bank Accounts in any Bank and or Banks in the name of the Trust in carrying out the objectives of the Trust. The operations of the Bank account shall be decided by the Board of Trustees from time to time. The Managing Trustee and any other Trustee as nominated by the Board of Trustees shall jointly operate Bank Accounts on behalf of the Trust. In their absence, any other Trustee may be authorized by the Board of Trustees, by a resolution, to operate the Bank Accounts. In case a document has to be submitted to the Bank Authorities for opening the Bank Account and also for operation, it shall be certified by the Managing Trustee and any one of the other Trustees authorised by the Board of Trustees.. No other Trustee shall have power to stall the operations of the Bank Account or raise objection for the operation of the Bank Account on behalf of Trust to the Bank Authorities and even if any objections are raised by any Trustee other than the Trustees authorised by the Board of Trustees, it shall not be binding on Bank Authorities or Investment operators and shall not be taken into cognizance. This provision is to avoid litigations in operation of the Bank Accounts and not to affect the regular work and Bank Transactions of the Trust.

XII. Investment of Trust Funds

1) The Board of Trustees shall have the power to invest the funds in acquiring the assets and properties of the Trust at their discretion in accordance with the provisions of the Income Tax Act, 1961 read in conjunction with clause IV

2) The Board of Trustees shall also determine from time to time, the amount it shall spend / invest in the various activities of the Trust in accordance with the Budget approved for the year.

3) The Board of Trustees shall keep separate accounts for the donations or funds received for specific purposes from Donors and shall use such funds for such specific purposes only. The Board of Trustees shall maintain separate records for these funds, their investment and utilization.

XIII. Accounts and Audit

1) The Trustee/Trustees shall keep Books of Account of all Income and Expenditure of the Trust and shall prepare the Income and Expenditure Account and Balance Sheet for every financial year and the same shall be open to inspection by any of the Trustees at all appropriate times. The financial year of the trust shall be from 1st April to 31st March of the subsequent year.

2) The Board of Trustees shall maintain true and correct accounts of the Trust.

4) The Accounts of the Trust as prepared at the end of every year shall be audited by a Chartered Accountant, who shall be appointed by the Board of Trustees and the audited accounts shall be placed at a Special Meeting of the Trustees, which shall be held before the end of the succeeding year.

XIV – Miscellaneous

01. Without prejudice to the irrevocability of the Trust, the Settlor or the Trustees if Settlor is not available, may by a supplemental deed or otherwise amend or modify any of the provisions of this declaration to remove any ambiguities or difficulties in carrying out the objects of the Trust as set out in clause 2 hereof and other provisions.

02. Any amendments / modifications of the terms of this deed shall be effected only with the approval of at least three of the Trustees for the time being in office or by obtaining their written concurrence by circulation of the proposal

03. The amendments or modifications can be executed by the Trustees and General Trustees and not necessarily by the Settlor and the First Trustees

4. The Trust may also apply for recognition as an eligible Trust/Institution with all Government Departments including Income Tax Department, Endowments Department, Ministry of Finance, Home Ministry, Ministry of Foreign affairs, Ministry of Education, Human Resources Ministry, Ministry of Health, Ministry of Science & Technology, Ministry of Information, Ministry of Rural Development, Ministry of Social Welfare and other State and Central Government Departments and other organizations including National and International Organizations / Agencies if required.

XVI. Indemnity

The Board of Trustees shall be indemnified for any act done by them in good faith in the course of the administration of the Trust.

XX. Dissolution

In the event of impasse situation in the operations of the Trust or the Trust determines that it is unable to run the Trust, the Trust shall opt for dissolution of the Trust and in the event of such a dissolution or the winding up of the Trust, the Assets remaining on the dissolution shall be transferred to another Trust, Society or Institution whose objects are similar to those of this Trust and having registered as eligible trust/institution u/s 12A of the Income Tax Act.

The funds, properties and the assets of the Trust shall not in any event be distributed or divided among the Trustees.

However such dissolution shall be approved by resolution by three fourth majority of the Trustees present or 6 Trustees whichever is higher.

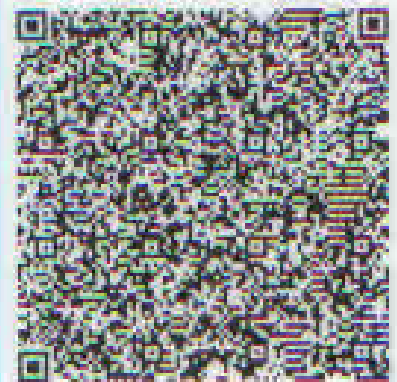
